HIGHLANDS COUNTY BOARD OF COUNTY COMMISSIONERS

Procedures and Policy for

VACATING EASEMENTS

(F.S. 177.101)

STEP 1 – Initial Review

The following items must be submitted to the County Engineer and the Critical Infrastructure Director as part of the initial review. The cost of this review will be Two Hundred Dollars (\$200.00), this is non-refundable. If the initial review is supported by the County Engineer and the Critical Infrastructure Director, those funds will be applied towards the total fee for the Vacation of Easement.

- a. Written Petition (Form Attached).
- b. Aerial Map showing the property line and the right of way. 1" = 200' scale aerial photograph/tax map overlay (available at the County Property Appraisers Office located on the first floor of the Government Center)
- c. Two Hundred Dollars (\$200.00) non-refundable fee.

The County Engineer will issue a letter of determination (objection or no objection). A copy will be forwarded to the Petitioner or representative for their information. Based on the provided determination, the applicant has the opportunity to move forward to the secondary review at their own time and expense.

STEP 2 – Requirements for continuing petition

The following items must be submitted to the Engineering office once the Initial Review is completed by the County Engineer and the Critical Infrastructure Director.

- a. Notice of Public Intent to Vacate Easement (Staff will provide)
- b. Resolution to Vacate (Staff will provide)
- c. One (1) copy of the recorded plat with the petitioned area, or border shaded in red (Staff will provide).
- d. Letters from all utility companies in the affected area of the subject road. If any easements are requested by any utility or the County, a 30-year title search, with all documentations attached, on the properties affected will be required.
- e. A letter from the Highlands County Road & Bridge Director (4344 George Boulevard, Sebring, Florida 33872) approving, or disapproving the closing of subject easement.
- f. The Petitioner shall attach a letter from the County Zoning Supervisor (501 South Commerce Avenue, Sebring, Florida 33870) stating "the closing of the petitioned

easement will not cause non-conforming use of any property.”

- g. It must be shown that the Petitioner owns fee simple title to the property on which the easement being vacated lies.
- h. Petition for vacation of easements either in whole or in part must be accompanied by receipts showing that all State and County taxes have been paid.
- i. One (1) copy of the Warranty Deed for the property the easement is on.
- j. Processing fee as adopted by the Board, made payable to the Highlands County Board of County Commissioners.
 1. Vacation of Easement – Secondary Review (includes \$200.00 from Preliminary review) \$1,000.00
Zoning Fee \$130.00
 2. Vacation of Easement Due to Existing Encroachments Review (includes \$200.00 from Preliminary review) \$1,200.00
Zoning Fee \$130.00

STEP 3 – Public Notice of Intent to Apply to Vacate Easement

The Board Meeting date will be set by the County Engineer and will be established once the application is deemed complete. The Notice of Public Intent will then be mailed or emailed to the Petitioner for publication. The Petitioner shall publish the Notice of Intent to Apply to Vacate Easement in not less than two (2) weekly issues of a general circulation of Highlands County prior to date stated therein for such hearing. “Proof of Publication” and affidavit must be received in the County Engineer’s office prior to the item being put into Granicus to go before the Board of County Commissioners. Petitioner, or a representative, may attend the Board Meeting to explain why the petition is necessary, when the Board meeting is held.

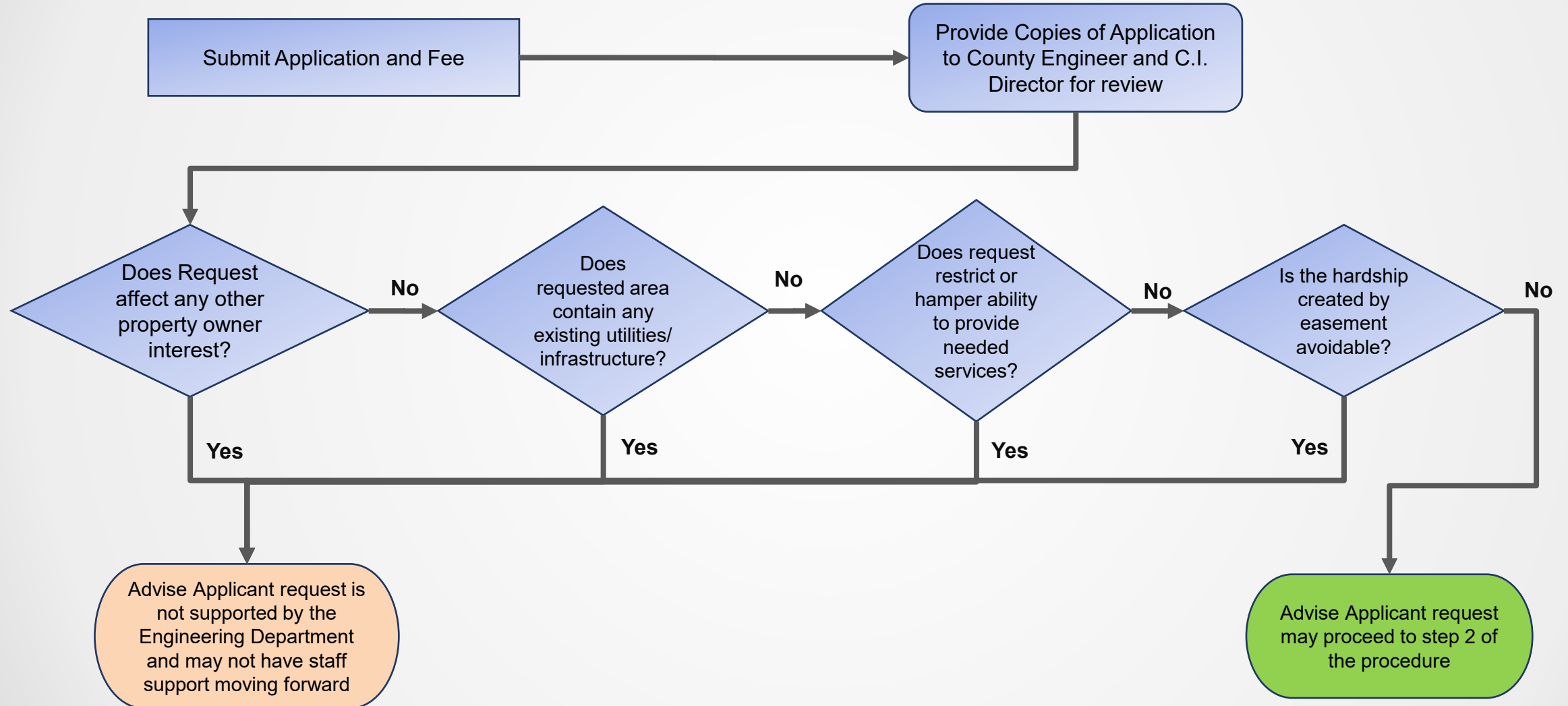
STEP 4 – What to do after the Board Meeting

The County Engineering Department shall forward the necessary originals of the following documents to be recorded to the Recording Department. Items needed prior to forwarding to the Recording Department include the following:

- a. Proof of Publication of Notice of Intent to Apply to Vacate an Easement
- b. Certified Copy of the Resolution to Vacate
- c. Check made payable to Clerk of Courts for the recording fee

The Engineering Department will forward the original documents to the Recording Department. Recording will distribute copies of recorded documents to the County Engineer’s Office. The County Engineer’s Office will send copies of the recorded documents to the Petitioner of record.

Easement Vacate Request Step 1 Process Chart

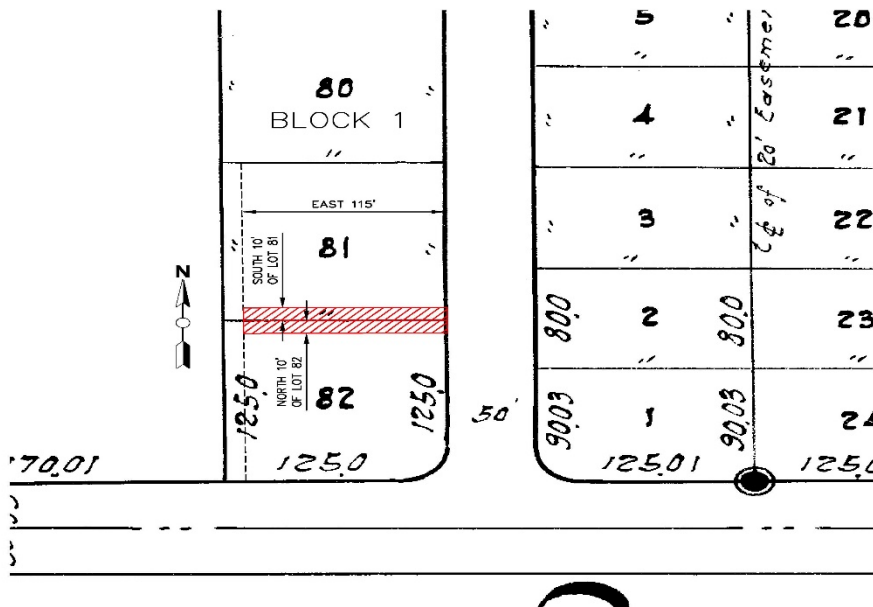


Below is a sample Legal Description to assist you in writing a Legal Description:

THE NORTH 10 FEET OF THE EAST 115 FEET OF LOT 82, BLOCK 1 AND THE SOUTH 10 FEET OF THE EAST 115 FEET OF LOT 81, BLOCK 1, ALL IN PLACID LAKES SECTION NINETEEN, ACCORDING TO THE PLAT THEREOF RECORDED IN PLAT BOOK 9, PAGE 14 OF THE PUBLIC RECORDS OF HIGHLANDS COUNTY, FLORIDA.

The area to be vacated is described first (THE NORTH 10 FEET OF THE EAST 115 FEET OF) followed by the Legal Description for the property where the Easement is located (LOT 82, BLOCK 1 AND THE SOUTH 10 FEET OF THE EAST 115 FEET OF LOT 81, BLOCK1, ALL IN PLACID LAKES SECTION NINETEEN, ACCORDING TO THE PLAT THEREOF RECORDED IN PLAT BOOK 9, PAGE 14 OF THE PUBLIC RECORDS OF HIGHLANDS COUNTY, FLORIDA.).

This diagram shows the area being described in the Legal Description above:



The Legal Description for the property where the Easement is located can be found on your Warranty Deed, if you do not have a copy of your Deed you can obtain a copy from the Clerk of Court. You could also get a Legal Description of your property from the Property Appraisers Office.
